April 8, 2024

The City Council of the City of Sulphur, Louisiana, met in regular session at its temporary location located at 1551 East Napoleon Street in the Council Chambers, Sulphur, Louisiana, on April 8, 2024, at 5:30 p.m., after full compliance with the convening of said meeting with the following members present:

DRU ELLENDER, Council Representative of District 1 NICK NEZAT, Council Representative of District 2 MELINDA HARDY, Council Representative of District 3 JOY ABSHIRE, Council Representative of District 4 MANDY THOMAS, Council Representative of District 5

After the meeting was called to order and the roll called with the above result, prayer was led by Mrs. Hardy, followed by the reciting of the Pledge of Allegiance led by Mrs. Thomas.

The Chairman asked if there were any changes to the minutes of the previous meeting. With no changes made, motion was made by Mrs. Hardy seconded by Mrs. Abshire that the minutes stand as written.

Motion carried unanimously.

Motion was then made by Mrs. Hardy seconded by Mrs. Abshire that item #3A be added to the agenda. There were no public comments.

The first item on the agenda a presentation by the Tellurian Sulphur High School LEAD. The LEAD addressed the Council and stated that this year's project consisted of helping at the Sulphur Senior Citizen Center on Maple Street. So far, they've spent \$16,000 out of their \$20,000 budget.

- \$2,000 on Thanksgiving gift cards for food.
- \$2,000 on Christmas gift cards for food and presents.
- \$700 on t-shirts.
- \$3,500 on sidewalks to get from one building to the next.

- \$1,000 on sound system so everyone can hear better during bingo, etc.
- \$7,000 on new 6-foot tables and chairs for general use.
- With the remaining \$4,000 they'll get more food for their pantry and new signage for daily menu items.

The next item on the agenda is a presentation by SWLA Safe Sleep Task Force and services they provide. Ms. Marler addressed the Council and stated that the top cause of death in infants is caused by suffocation in their cribs. They've had numerous fund raisers for crib and sleep sack give-aways and anyone can get one no matter what your income is. They have the funding they just need the volunteers to educate people on the dangers. They've helped displaced families during the hurricanes and floods. Their numbers have gone down about 65% since they've started this program. They educate middle schoolers now since so many of these kids are primary care givers for their siblings. They've met with all the local fire departments educating them and helping them by giving them pack n plays and cribs. They do have monthly classes on education and asking anyone who wants to volunteer to please contact their office.
